SERVICES PROVIDED

Capital Health's Pharmacy Department provides services to Regional Medical Center in Trenton, Capital Health Medical Center – Hopewell, and satellite Emergency Department at Capital Health – Mercer 24 hours a day, 7 days a week. Integrated computer systems and automated dispensing technology are available hospital-wide. The Pharmacy Department is actively involved in protocol development and implementation, drug information, continuing education seminars, Code Blue participation, and preceptorship of students from multiple schools of pharmacy.

PROGRAM GOALS

APPLICATION PROCESS

Eligibility

- Graduate of an ACPE-accredited College of Pharmacy with a Doctor of Pharmacy degree or equivalent
- Eligible for pharmacist licensure in NJ. Obtained no later than August 31.
- US citizen or legal resident

Documentation

- Official College of Pharmacy Transcript(s)
- Curriculum Vitae
- Cover Letter/Letter of Interest
- Three Letters of Recommendation
- Completed Application Form

Deadline

All materials must be submitted via PHORCAS no later than January 15.

Upon completion of the selection process, applicants will be invited for an on-site interview.
