

## **Rutgers School of Dental Medicine SPICE Cases. Oral Medicine Case Review Sessions – Fall 2022-Spring 20223**

**The case review will take place online. Caroline Harris (Program Coordinator Office of Interprofessional Programs, RBHS) will send you the meeting link the week before the case discussion.**

### **Introduction and Objectives**

The SPICE (Special Populations Interprofessional Care Experiences) was started by a grant that was awarded to the Rutgers School of Dental Medicine (RSDM) in 2015. *The oral medicine cases include patients with multiple comorbid medical conditions.*

Faculty from the Schools of Dental Medicine, Pharmacy, Social Work, Medicine, Nursing, and the Health-Related Professions (nutrition and dental hygiene) have agreed to facilitate the case reviews and have their students participate in the case reviews. Students will attend a two-hour IPE discussion and will present their own discipline's perspective in a group discussion format in determining optimal treatment during the case review. The experience will also provide students with the opportunity to explore and learn about other disciplines' perspectives.

***At the conclusion of the case review, students will be able to:***

- Describe the roles of other health professions as members of the health care team.
- Demonstrate shared decision making.
- Demonstrate effective listening and communication skills.

### **Requirements for Pharmacy Students Obtaining IPE credit**

Students will receive case information in advance and then attend a 2-hour case discussion with students from the dental, medical, nursing, nutrition, and pharmacy school. The case will be facilitated by at least 2 faculty, one of which will be a dental faculty member. We can have one or two pharmacy students attend each event and you can work together to help collect reference material and prepare your suggestions prior to the event. It is advisable to review your case with the pharmacy faculty facilitator that is assigned to your meeting day. If there is no pharmacy facilitator assigned for your week, you should meet with your rotation preceptor. You should allocate about 2 hours to prepare for the event. If you attend unprepared, I am notified by the faculty facilitator. Please make EMSOP proud of you.

**At the event:** You will discuss the case with the aid of faculty facilitation. Please ask the faculty members to provide any additional information you may need to complete your assessment and plan for the case discussion. Actively participate in the discussions as the faculty facilitator will be evaluating your contribution to the team. There should be someone at the meeting to validate your parking.

**After the event:** Complete the online survey e-mailed to you by the dental school while you are still in the dental building. Then complete IPE documentation sheet for your portfolio soon after

the event so that you do not forget the details of the event.
