- › Doctor of Pharmacy degree
- › Participation in American Society of Health-System Pharmacists matching program
- › Eligibility for licensure in New Jersey

- › Curriculum vitae
- › A letter of intent/personal statement
- › One-page document describing your role and responsibilities on clinical rotation(s), including number of patients followed on a daily basis and examples of autonomy and significant interventions
- › Three letters of reference
- › Official transcripts
